President's Report Year 2018

The Jarrahdale Community Collective (Inc) has been running in Jarrahdale for close to 12 months. The JCC's mission has been to foster and support the community spirit by creating a socially sustainable community, encouraging community activities and working to preserve Jarrahdale's natural and built resources.

The committee is relatively young and jumped at the opportunity to develop the community spirit. I have had the pleasure of working with these ladies and our members, which was the most inspiring part of being in my position. As a group we have learned a lot in the last year and developed, or possibly revealed, new skills.

This was a developmental year for the JCC committee, establishing an incorporated community group and calling on the community for support. Through meetings and consultation with the community we believe we have gained a good indication of what the residents of Jarrahdale would like to see for the future of their town. With this information, we have established sub circles to represent the interests of our members. These groups are: Finance & Fundraising, Environmental, Sport & Fitness, Business & Tourism and Social. Looking forward into 2019, we hope to have more functions and events organised by the participants of the circles.

We have been holding quarterly meetings for the committee and members of the JCC, which consists of quite a varied age and interest range. Late last year the committee introduced guest speakers at the meetings based off the interest of our members, with a very positive response and will continue doing it.

We were fortunate the past members of the Jarrahdale Community Association recognised our hard work and dedication in developing the JCC and donated the remaining monies of the JCA to the JCC. This money is much appreciated as it allows for the JCC to start with one foot forward.

Behind the scenes, the committee members have been working with our local groups to assist with grants, communications with the SJ Shire and other matters. We strongly believe that we need to support and connect the smaller groups of Jarrahdale as it will benefit the larger community.

The committee members have also started to establish relationships with the Shire of Serpentine Jarrahdale, National Trust, Alcoa, Councillors and other prevalent members of the community. We have been in discussion with multiple members of the SJ Shire regarding large and small events held in Jarrahdale, grant money dispersement and general ongoings. We have been in contact with the National Trust regarding the Mill Managers House, Historical Park and Mill and have been in meetings with Alcoa regarding mining around the Jarrahdale area.

We hope our influence results in the favour of our members, and larger community, as well as the natural and built resources our town already has on offer.
